## **CALL TO ORDER:**

President Heffron called the meeting to order at 3:00 p.m.

## **MINUTES:**

By MOTION and second, the Board accepted the December 20, 2017 Minutes as presented.

#### MATTERS BEFORE THE BOARD:

Consideration of Resolution No 2018-1-1 to appoint Katie Nicholls as Designated Election Official and authorization to cancel election: President Heffron presented this matter to the Board. By MOTION and second, the Board approved the Resolution to appoint Katie Nicholls as Designated Election Official and authorized her to cancel election if appropriate as presented.

**Consideration of Resolution No 2018-1-2 to call a regular District election:** President Heffron presented this matter to the Board. By **MOTION** and second, the Board approved the Resolution to call a regular District election as presented.

Consideration of Resolution No 2018-1-3 to designate public notice posting places: President Heffron presented this matter to the Board. By MOTION and second, the Board approved the Resolution to post public notices at the Three Lakes District Office, the Columbine Lake HOA office and the Columbine Lake Pool Community Bulletin Board as presented.

Consideration of Resolution No 2018-1-4 to authorize signatories for accounts held at Grand Mountain Bank: President Heffron presented this matter to the Board. By MOTION and second, the Board approved the Resolution to authorize signatories for accounts held at Grand Mountain Bank as presented.

Recommended changes to Rules and Regulations: Article 8.5 Service Charge – Late Fee Assessment: By MOTION and second, the Board approved the Change to Article 8.5 Paragraph C, Service Charge – Late Fee Assessment adding the following wording – A late fee of 5% of the assessment shall be charged on the unpaid balance, non-compoundable for five consecutive months, or part thereof, to any account whose assessment is not paid in full by March 31, or until paid in full, whichever is the earlier.

**Legal Representation:** Discussion ensued regarding Stan Cazier's retirement and recommendation of Kent Whitmer. Board directed Katie to call Mr. Cazier to see why Mr. Whitmer was recommended, and determine his water right experience, and invite Mr. Whitmer come to a future meeting to discuss a possible changeover, his professional experience and fee schedule. The Board further directed Katie to let Mr. Cazier know not to destroy District files.

**PUBLIC COMMENT:** No public present.

#### **CHIEF OPERATOR REPORT:**
